Starting **April 1st**, we will officially transition from recreational gifting to a fully licensed **medical cannabis dispensary** in Washington, DC. How to Get Your DC Medical Cannabis Card

Becoming a registered medical cannabis patient in DC is a straightforward process, and the best part? **The application fee is waived until March 20th 2025!** Here's what you need to do:

- 1] **Apply Online** – Head over to the Alcoholic Beverage and Cannabis Administration ([ABCA](#)) website to complete the medical cannabis application. (Click the hyperlink)
- 2] **Obtain a Medical Cannabis Recommendation** – Depending on your age, there are different requirements for certification:
 - **Ages 18-20:** You must obtain a healthcare provider's recommendation from a licensed doctor, nurse practitioner, or physician assistant and include it in your application.
 - **Ages 21+:** You can self-certify your medical cannabis use online without needing a healthcare provider's recommendation.
- 3] **Submit Your Application** – Upload the required documents online and receive your **digital medical card**, valid for up to **6 years**.
